Adam Nickels, USBR Deputy MP Regional Director, reported on the following: CVP Water Operations and Hydrology Update; Future reliance on Section 3F provisions for surplus flow diversion opportunities with a TBD pricing structure prior to March 1, 2024 (NOD discussions regarding tier triggers with NCAO forthcoming); Update on status of 2024 BIL funded Extraordinary Maintenance Projects, with more information regarding full list of projects, estimated costs, and other details to be provided prior to finalization, letters of support and/or concern welcomed; Update on the status, timing, and overview details related to the Reconsultation on the Biological Opinion for the Long Term Operations of the CVP/SWP, focus on the new Shasta Reservoir Operations and carryover requirements, overview of effect on water allocations and settlement contractor provisions; Update on status of water transfers in regard to efforts to effectuate a new long term water transfer environmental document; update on accelerated transfer program – clarifying that all settlement contract, repayment contract, and water service contract supplies are eligible for transfer between in-basin contractors pursuant to the accelerated transfer program.
