Don Babb and Aaron Hall, TCCA O&M Chief and Red Bluff Supervisor, A. reported on the following O & M activities: Road grading from South Avenue to Liberal Avenue (Corning Canal), Kirkwood Road to Stony Creek; Vegetation removal Chittenden Ave to Rawson Road (Corning Canal); Road repair South Avenue to Rawson Road; Burning prism Cortina Road to Hahn Road; Vehicle and equipment maintenance and repairs; Drain check 2 for inspection, repairs and silt removal; Drain Funks Reservoir; Stolen ATV removal by CHP Hahn Road; Purchased preventive maintenance software for Pumping Plant; Clean all VFD filters at Pumping Plant; Finished removing fish screes from river; Winterized shops, equipment and the Corning Canal before the big storm; Assist with Salmon pet pen project; All diversions are suspended for Winter Maintenance Shutdown; Meter readings; Grate cleanings; Safety meetings. Upcoming activities: Finish spray truck (needs calibration and speed control); Silt removal Check 2 TC Canal; Concrete repairs Check 2; Haul gravel for road repairs Road 65, 69 and Maxwell Sites Road; Sac River Project with RD108 and GCID; Remove hydraulic cylinder from Check 15 for repair; Ongoing work on erosion and tree removal on Coring (2024 review); Ongoing inspections and maintenance of TC and Corning Canals,

Red Bluff and Willows complexes and Pumping Plant; Repair gate 13 on Corning; Continue vegetation removal on Corning Canal; Replace bearing oil in motors at Pumping Plant.
